

Integrated System of social, economic and environmental information, oriented towards demand, with intensive use of the ICTs and according to international norms

Undermining trust

	Mode of undermining	Examples of the political intervention at INDEC (2007-2015)
1	Mission of the statistical service	Concept of "militant statistics"
2	Financial resources and controls	Lack of funding for statistics
3	Staff	Replacement of staff with political supporters
4	Supression or changes in series	Supression of poverty and indigence statistics (2013). Alteration of the CPI. Unexpected change of GDP base (March 2014)
5	Definitions, concepts and methodology	Ad hoc methodological changes
6	Terms and nomenclature	CPI. Labour market. Foreign trade
7	Altering specific numbers	Alteration of statistical series (CPI, poverty, GDP)
8	Extent and timing of release data	Unclear dissemination schedule. Bases not published
9	Threats to confidentiality	Political pressure to reveal informants
10	Use of NSO for politics	Defence and promotion of militant statistics
11	Campaigns to discredit	Persecution of former officials and analyists

W. Seltzer (UN, 1994) defined eleven modes of institutionally undermining an NSO. The political intervention in Argentina included all of them.

FUNDAMENTAL PRINCIPLE 4

Political interference (2007-2015)

Prevention of misuse was "misused"

- Campaigns to discredit
- False dilemmas (i.e. Inflation vs CPI)

Rebuilding trust (2015-2019)

Speaking out was crucial for legitimacy

- Prevention in the use of 2007-2015 historical series
- Controversies with national and provincial authorities

El INDEC, en el marco de las atribuciones conferidas por los decretos 181/15 y 55/16, dispuso las investigaciones requeridas para establecer la regularidad de procedimientos de obtención de datos, su procesamiento, elaboración de indicadores y difusión.

- The more institutionally solid an NSO is, the more chances for principle 4 to be applied
- NSO gains legitimacy by preventing misuse
- Strong leadership is crucial to face controversies
- Explain, explain, explain
