Conference Program

We now have a full program for the conference. There will be 3 plenary sessions (one on each day), 13 invited sessions, 11 contributed sessions and 2 workshops.

The rich program includes Ola Rosling from Gapminder, a plenary session on Measuring progress for Arab women, invited papers on topics such as the Data Revolution, Fundamental Principles, Innovation in GCC Statistics, Dissemination in the European Statistical System, Statistical Literacy and the 2030 SDG Agenda, and lots more.

The over 50 contributed papers also cover a wide range of topics. While presenters come from across the world, it has been great to see great representation from across the GCC region. See the IAOS2016 website for the full programme.

World Bank Fund Support

The closing date for applications for World Bank funding to attend this year's IAOS 16 conference is **September 8, 2016**.

To be eligible for support, applicants must

- a) be a permanent resident of a developing country
- b) be a member of the ISI and the IAOS
- c) have a role in the conference such as speaker, session organiser, discussant or chair.

d) have not received funding from the IAOS or World Bank to attend a statistical conference previously (or at least for the last four (4) years) e) not be receiving funding from another source to attend the IAOS16 conference

SJIAOS - Update

SJIAOS September 2016 issue

The <u>September 2016 issue</u> is now available. The theme of the issue is 'Data Fabrication'. There have been a series of meetings, seminars and workshops on this topic in the past year in the Washington, D.C. area resulting in several papers. Four of these papers are in this issue with an <u>introduction</u> prepared by one of our associate editors, Steve Koczela. He was assisted by Fritz Scheuren. We will publish more in future issues.

The September issue also features an <u>interview with Mr. Jean-Louis Bodin</u>. Mr. Bodin is one of the founding members of IAOS and its second president. We also publish a <u>conversation between Gary Shapiro</u>, one of the <u>co-founders of Statistics without Borders (SwB) and a researcher with SwB, Dr. Nilupa Gunaratna</u>. They talk about creating continuing and sustainable volunteer organizations. Finally, we have an <u>interview with H.E Butti Al Qubaisi on leading SCAD and hosting the IAOS 2016 Conference</u>.

The remaining manuscripts in the issue cover topics that should have appeal to a wide audience of official statisticians. They were prepared by authors from many different countries: Austria, Italy, the Netherlands, Russia, Sweden, Turkey, and the United Kingdom.

IAOS and Inter-American Statistical Institute (IASI) Joint Project

Earlier this month, the editor-in-chiefs of the IASI and IAOS Clyde Charre and Dr Kirsten West, signed an agreement to publish each other's manuscripts in their respective journals. With regular intervals, the SJIAOS will select a manuscript from Estadistica to reproduce and Estadistica will do likewise. Evelio Fabbroni, the Executive Director of IASI, and Fritz Scheuren, Editor-in-Chief Emeritus of SJIAOS were instrumental in establishing this agreement of collaboration. The arrangement will allow greater dissemination at the international level of papers of interest to both organizations. Right now we are working out all the practical details of implementing this agreement. The first manuscript is expected in the December 2016 issue.

SCORUS Update

The annual conference of the IAOS Standing Committee on Regional and Urban Statistics (SCORUS) co-organised by Statistics Portugal, Eurostat, SCORUS and OECD took place in Lisbon from 29 June - 1 July, 2016. The theme of this conference was "Indicators for territorial policies: closing data gaps by using traditional and new sources and methods".

The conference aimed to address the development and progress of regional and urban statistics under the scope of the cross-cutting issues that have been put forward in European and global agendas. It was an opportunity to discuss the place of territorial statistics within the scope of the strategic challenges set up by the EU, OECD and UN agendas. These include the use of administrative data, geospatial information analysis and modeling, multi-source statistics, open data and big data, so as to produce relevant indicators for the monitoring of territorial policies.

More than 100 participants from both national and international organisations attended; bringing together professionals from National Statistical Institutes, public administration agencies, universities and reference research centres. The conference strived to promote the sharing of knowledge and experiences on the most recent developments, opportunities and challenges for regional and urban statistics and tried to promote the co-operation between producers, users and

researchers around the topics discussed. All of the presentations were followed by a brief debate and participants greatly contributed to the conference stimulating discussions.

Global Partnership on Sustainable Development Data (GPSDD)

In late 2015, the IAOS accepted an invitation to be one of the stakeholders in the GPSDD initiative. The GPSDD initiative was established to convene and facilitate stakeholders across sectors, countries and regions worldwide, in order to galvanize and sustain political commitments, align strategic priorities and norms, strengthen capacities, foster innovation and build trust in the booming data ecosystems of the 21st century.

These in turn are seen as having a key role in the provision of indicators to support the 2030 SDG agenda.

To date, IAOS has focused its work on data principles, where the GPSDD seeks to promote new data principles and norms when needed and strengthen those that already exist.

GPSDD involves public and private sector, as well as NGOs and academics. This has the potential to change the arrangements for how information, including official statistics are used to inform and monitor decisions.
